Subject: - PREFERENTIAL TRADE AGREEMENT (PTA) AMONG THE D-8 MEMBER STATES.

Reference Ministry of Foreign Affairs' letter No. PC (D-8)-8/11/2010 dated 22<sup>nd</sup> July, 2012 on the subject noted above. It is informed that Pakistan's offer list has been transposed under HS Code 2012 and the concessions under the list remain the same. (Copy of the list is enclosed).

2. As committed in the Supervisory Committee meeting, Pakistan is ready to notify the first installment of tariff reduction by 15<sup>th</sup> August, 2012 on a 10 days prior notice by the Secretariat. The concessions, would, however be extended to member countries having submitted their revised offer lists as well as agreed to the Rules of Origin.

3. Regarding the draft on "Dispute Settlement Document" prepared by Turkey, Pakistan would convey its comments on the draft after consulting legal experts.

4. The Ministry of Foreign Affairs is requested to inform the D-8 Secretariat accordingly.
